

**NOTICE OF PUBLIC HEARING

The proposed budget is also available for review on the Lido and Point Lookout Fire District's website at [www.pllfd.org](http://www.pllfd.org). Copies of the proposed budget will also be available on the night of said hearing.

*NOW*, therefore, BE IT FURTHER RESOLVED, that the Board of Fire Commissioners of the Lido and Point Lookout Fire District will hold the Annual Fire District Budget Hearing with reference to the Annual Fire District Budget for fiscal year 2018 on Tuesday, October 17, 2017 commencing at 7:30 PM at the Fire Headquarters Building located at 102 Lido Boulevard, Point Lookout, New York.
