

***NOTICE OF PUBLIC HEARING
LIDO AND POINT LOOKOUT FIRE DISTRICT

NOW, THEREFORE, BE IT RESOLVED that the Board of Fire Commissioners of the Lido and Point Lookout Fire District has adopted a proposed Annual Fire District Budget for 2017 as of this date for purposes of discussion and review at the Budget Hearing to be held on October 18, 2016 and a copy of the proposed budget is available at the Office of the Town Clerk of the Town of Hempstead and at the Office of the Lido and Point Lookout Fire District Secretary at 102 Lido Boulevard, Point Lookout, New York, where it may be inspected by any interested person by appointment scheduled by calling 516-432-6645. The proposed budget is also available for review on the Lido and Point Lookout Fire District's website at www.pllfd.org. Copies of the proposed budget will also be available on the night of said hearing.

NOW, THEREFORE, BE IT FURTHER RESOLVED that the Board of Fire Commissioners of the Lido and Point Lookout Fire District will hold the Annual Fire District Budget Hearing with reference to the Annual Fire District Budget for fiscal year 2017 on Tuesday, October 18, 2016 commencing at 7:30 PM at the Fire Headquarters located at 102 Lido Boulevard, Point Lookout, New York.
