Chief's Report:

The quote received is \$450 per tire, \$200 per mounting on new rim and \$393 shipping for a total cost of \$1,693 Motion by Comm. Naham to purchase two new tires mounted on new rims for 2561 at a total price of \$1,693.00 which includes shipping. Seconded by Comm. Paz. Accepted 4-0.
