- 2. Gave 2 copies of May PCRs to District Secretary.
- 3. Gave May log sheets to District Secretary.
- 4. Turned in monthly mutual-aid report.
- 5. Took 2571 to Conte Monday. They called saying they do not have the part for the recall and will call us to reschedule.

Chief's Report:

- 1. Turned in gas receipts for 2500, 2501, 2502 and 2571.
- 2. Bill for Memorial Day breakfast. District contributes \$500.
- 3. Submitted bill for charger in the amount of \$76.02.
- 4. Elite is coming down the 26th of the month to measure for uniforms. Lester Kappel and Joe Mahoney need uniforms and should be added to the list. Joe also needs badges.
- 5. Need Department patches. Comm. Thompson said he will order patches and parking stickers.
- 6. Also need to order five (5) proble shields.
- 7. Fire School went very well last night. We looked very professional and a compliment to the entire Department.
- 8. Turned in a copy of the social media policy. Comm. Weitz thinks there is too much in the policy and thinks it should be turned into two policies. Board will review and get back to Chief.

- 9. Policy regarding EMS night stand-by list needs a little more work. Especially involving LOSAP.
- 10. Still checking on number of members we will have for the fireworks on June 28th. May need a stand-by unit.
- 11. Comm. Weitz asked Chiefs to get information out about members using their blue lights.
- 12. Comm. Weitz asked that he get an e-mail this week about the date for the Deus training. Chief said he will get date and that there are 10 members on the list.
- 13. Comm. Weitz stated that it is believed the 255 problem is a grounding issue. Cummins is coming in on Monday. If the grounding issue is repaired, 255 will be able to be put back into service.

Comm. Naham:

- 3. Mentioned looking into an intern from one of the colleges to assist in the office to get the files cleaned out and ready for digitalizing, etc. Discussion followed.
- 4. Went to a meeting regarding Long Beach re-opening the hospital. Discussion followed. Comm. Weitz asked that a letter be drawn up for the Board's review.
- 5. Discussed gardening maintenance. Will draw up a proposal.

Comm. Paz:

- 1. Discussed the hydrant issues. Have not heard back at this point.
- 2. Discussed that FP has been asked to assist at the Fun Run being held on 8/3 as a fund raiser for the Point Lookout Park. This is a Chief's issue. Will get together with the Chief to set this up.

Comm. Thompson:

- 1. New radio in 252 working well.
- 2. Thanked Comm. Naham for a good job with the landscaping at HQ.
- 3. Gave the Captain of Lido the on-spots for 252 and they have been taken to Lido House and stored `with the on-spots for 255 and 258.
- 4. Went on Stryker's website regarding PM for stretchers. M Star who does all their work charges \$115 per stretcher with a \$70 fuel charge. Comm. Weitz requested that they be asked to waive the fuel charge.
- 5. Spoke about members speeding when responding to calls and about too many blue lights on member's vehicles.
- 6. Asked about setting a date for a dinner for Ex-Comm. Tom Manning. Discussion followed.
- 7. Asked about Renegade's 50/50 Raffle. Chief will check on this.
- 8. Congratulated Department for a nice job at fire school.

Comm. Weitz:
